

Entry Procedure:

M-NET - THE BACHELOR SA TERMS AND CONDITIONS FOR ENTRY

1. Fill out the form and upload your photos at www.mnet.tv/thebachelorsa
2. Once your entry has been completed and accepted, it will be evaluated and assessed.
3. Should your submission be shortlisted by M-Net, in its sole discretion, you will be advised by the production company and more information will be requested from you.

Terms and Conditions:

1. Entries open on 25 June 2019 and will close at 23:59 on 11 September, 2019.
 2. The Producer reserves the right to extend the closing date according to the needs of the show.
 3. You need to be over the age of 21 at the time of entry to apply to participate in the series.
 4. You should be South African citizens or have a valid permit or permanent residence status in the country of South Africa.
 5. You should not be married.
 6. Multiple entries per person are not permitted.
 7. Entries are only valid if correctly submitted on the entry platform.
 8. Your valid submission of your entry constitutes your binding acceptance of the terms and conditions contained herein.
 9. You will only be contacted by the production company for further details should your entry be shortlisted.
10. Further details to be required from you will be your full names, contact details (email and phone), next of kin details and identity number. You will not be asked for any banking details. You will further receive a release document to be fully signed and returned by you to the production team granting us your consent to entry and/or to be part of the next phases of M-Net's The Bachelor.
11. If any of the terms and conditions are not adhered to, your entry will be considered incomplete and will be null and void.
12. Should your entry be successful and shortlisted, the production company will contact you within 60 days of receipt of your application.
13. It is your responsibility to ensure that any information which you provide to us is accurate, complete and up to date.
14. By submitting your entry, you are granting M-Net and its production company permission to use your information to promote you and/or M-Net's The Bachelor on any other platform of its choice. You agree that your entry may be edited, modified, added to or deleted, juxtaposed with any other material and that any other changes to the entry may be made at the sole discretion of M-Net. You agree further that M-

Net may use your name, image, likeness, any photograph, voice, sobriquet and signature in connection with your entry and/or M-Net's The Bachelor.

15. All publicity, digital and social media activity around your involvement in M-Net's The Bachelor will be done by M-Net from the date of your audition until three months after the final broadcast of the series, unless otherwise indicated by M-Net.

17. M-Net and its affiliates are not responsible for any injury or damage to your or any other person's computer, mobile telephone or other device used by you to enter into, or obtain any materials related to the entry.
18. M-Net and its affiliates are not responsible for any errors and/ or omission in any information submitted by you.
19. Under no circumstances shall the producers, M-Net or its affiliates be liable to anyone who participates in the production of M-Net's The Bachelor for any indirect or consequential loss howsoever arising which may be suffered in relation to your participation in the production of M-Net's The Bachelor, whether as a result of any negligent act or omission or any default on the part of the producers or otherwise.
22. You warrant that in making your video, no third party rights including intellectual third party rights were infringed and/or violated.

23. You warrant that you have the capacity to agree to these terms and conditions and further that if successful, you are at complete liberty to participate in M-Net's The Bachelor and to comply with these terms and conditions and that doing so will not infringe upon the rights of any other person. You further warrant that the information you have provided is true and accurate. The producers or M-Net may disqualify you should you breach the aforesaid warranties.

24. By participating in this call to entry you accept and agree to abide by these rules, terms and conditions set out herein and such rules and conditions that the producers or M-Net may issue in relation to further phases of M-Net's The Bachelor from time to time.

25. These terms and conditions are governed by South African law and the South African courts shall have sole and exclusive jurisdiction in respect of all matters (including disputes) arising herefrom.
